Terms of Contract:

1. This constitutes an order for event Videography. It is understood that the footage recorded by A Story Book Event Services are our copyrighted work and may be used for advertising, display, or any other purpose thought proper by us.
2. Although all care will be taken with the master taped footage recorded at the event A Story Book Event Services limits any liability for loss, damage or failure to deliver the final product for any reason to return of all retainers and deposits made.
3. It is understood that A Story Book Event Services is the primary videographer at the event. Any other videographer, amateur or professional, must yield their activities to our discretion, and not interfere in any way with our work. It is also understood that any videographer must also cooperate with our team of professionals, in order that the event may be videographed properly. Any breach of this agreement will constitute a reason for non_completion of the job with no liability to us, and loss of initial deposit by the client.
4. Upon signature, we reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, all retainers are nonrefundable, even if date is changed or event cancelled for any reason.
5. Unless otherwise stated, A Story Book Event Services owns the master dv tapes and all rights to reproduce for advertisement purposes.
6. Should we be unable to fulfill this agreement due to serious illness or other such physical handicap, or due to accident or events beyond our control, all retainers and deposits shall be refunded and will make every effort to find a replacement videographer for the event.
7. Any Park/Hotel entrance fees are to be paid by the customer.
8. All dues must be collected two (2) weeks prior to the event. If balance on the contract is paid two (2) working days or less before the event, the amount must be paid in cash.
9. All Videography Packages include travel within Miami-Dade County. For Broward and Palm Beach County, we charge a fixed rate of \$75.00. For other Counties within Florida, we charge \$0.35 per mile, plus \$50.00 per hour of travel time. For Caribbean Island, Bahamas, or any other state within the US, the client is responsible for all travel costs including, flights, accommodation, etc.
